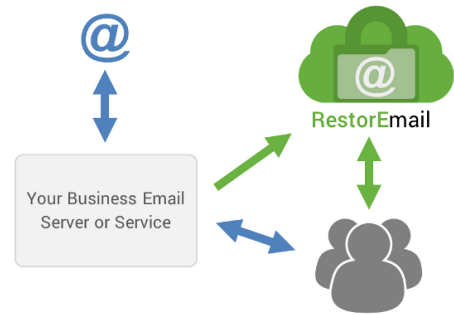

How Continuity Works

Email received is sent on to your email server *and* to the RestorEmail cluster, where it is immediately indexed and replicated to our geographically diverse data centers. Internal and outbound email can also be archived, indexed and replicated with a simple configuration change on your email server.

Archived email is stored for 30 days with Continuity edition or for as long as your policy (or legal hold override) requires with Full Archiving.



Which Edition is Right for You?

Continuity

If you're only concerned about recovering email during server outages or if your employees delete email that they shouldn't, you'll want RestorEmail Continuity.

It keeps a 30-day indexed, searchable and replicated rolling archive of incoming and outgoing email; critical to keep your business moving during disasters and to recover easily after.

Full Archiving

If you need long-term archiving (for example, to comply with document retention and eDiscovery) you'll want RestorEmail Full Archiving.

You can set different retention settings for messages that match various criteria, override them to comply with legal holds, and then produce emails that match eDiscovery requests.
